THE IMPERIAL GLEE CLUB

Cache Valley's historic men's chorus, The Imperial Glee Club, was founded in 1916. The Imperial Glee is celebrating its 97th Season, making it one of the oldest continuously performing men's choruses in the United States. Its members come from the various communities of Cache Valley. Under the capable direction of Warren Barton, the club is dedicated to fostering four-part male choral music and it meets one night each week for rehearsal.

The club has a rich history which includes performing at a regional Rotary Club conference in Seattle, Washington in 1928. The club performed minstrel shows at the Capital Theatre in Logan, Utah, during the WWII years, under the direction of Dr. Walter Welti.

Today, the Imperial Glee performs regularly for civic events, such as The Star-Spangled Celebration in Hyrum, each 4th of July, Veteran's Day Concerts, and public concerts in the Logan Tabernacle each Spring and at Christmas time. As a service organization, the Club accepts invitations to sing at local churches, civic organizations, rest homes and public gatherings. Last September, the Club performed a Military Memoriam at the Cache County fairgrounds where a replica of the Vietnam Wall was displayed, to honor those who have fallen in defense of this country. Each year, the Imperial Glee Club performs at 25-30 venues throughout Utah and Southern Idaho. In four years, The Imperial Glee Club will celebrate their Centennial Season.
