The Executive Board is pleased to announce our opening speaker for the 2013-2014 season is newly appointed Senior Vice President for Academic Affairs. Dr. Ruth Watkins. We anticipate a large turn out so please make your reservations by the October 2, Wednesday deadline with our new Treasurer, Hyram Highham.

Ruth V. Watkins joined the University of Utah leadership team in August 2013 as the Senior Vice President for Academic Affairs, with faculty appointments in the Department of Communication Disorders and



the Department of Linguistics. Prior to joining the Utah leadership team, Dr. Watkins served as the Harry E. Preble Dean of the College of Liberal Arts and Sciences at the University of Illinois from 2009-2013. Dr. Watkins was a member of the faculty at the University of Illinois from 1993-2013, with a primary appointment in the Department of Speech and Hearing Science, and courtesy appointments in Linguistics and Psychology. During her years at Illinois, Dr. Watkins performed a variety of academic leadership roles, including Associate Dean for Academic and Research Affairs in the College of Applied Health Sciences from 2000-2003, as Associate Provost from 2003-2006, and Vice Provost from 2006-2008. As Associate Provost, Watkins provided guidance to the campus on undergraduate education; as Vice Provost, she was Chief of Staff and provided leadership in the areas of academic affairs, faculty affairs, undergraduate education, and strategic

planning and implementation.

Dr. Watkins' scholarship focuses on communication development and disabilities, including prevention of disability in populations who are at risk, and early childhood stuttering. Her research and training programs have been funded by the National Institutes of Health and the U.S. Department of Education, and she has received recognition for teaching excellence at departmental and college levels. Most recently, Dr. Watkins served as the principal investigator on a grant from Lumina Foundation for Education, designed to expand opportunities and success for community college transfer students in large public research universities.

- Free parking in Campus "Visitor" lots
- Half-price University Parking permits through Commuter Services
- Free admission to Preview Night Performance of main stage productions of Pioneer Memorial Theatre
- Listing in the University General Catalog and the University Directory
- Eligibility to receive faculty research grants from the University Research committee
- Discounts arranged by the Emeriti Club, such as the special activities published in the Newsletter

PMT Parking Problems

Parking is also available in the Campus Bookstore visitor's lot. This parking problem will continue throughout the current academic year.

Upcoming Special Events and Vouchers Henry Wolking, Special Events Coordinator

The School of Music is once again offering emeriti members and up to two guests each \$1 vouchers for all School of Music concerts, including the Virtuoso series during the upcoming school year. Quite popular were last year's Orchestra and Choirs Holiday Concert and the traditional Halloween orchestra concert. The vouchers may be redeemed at the LGCH (Libby Gardner Concert Hall) box office one hour before the concert or anytime at regular box office hours at Kingsbury Hall. Each voucher may be redeemed for one general admission ticket without any further processing fees. With processing fees, general admission tickets cost \$10, so members receive a substantial savings. Remember all tickets are first come first served, so redeeming your voucher early ensures you a seat. Should the tickets be sold out when you go to redeem your voucher, the voucher may be used for any other school of music event throughout the year. CLUB FINANCIAL REPORT

The Club's financial condition is sound, and it is the aim of our leadership to continue to insure our financial viability for this and future years.

Club funds come from two separate sources:

- 1. The University of Utah. The Club receives a fixed annual budget allocation from the University of Utah sufficient to meet the expenses of newsletter printing, paper, envelopes, and postage expenses for those copies sent by mail. Postage costs have again increased this year with little respite in sight. Receiving your newsletter by e-mail helps to manage these costs. Our University stipend is exhausted annually, while the University's budget must serve everincreasing demands.
 - **2. Member Dues.** Club dues support the following purposes:
- a) Monthly speakers and new emeriti are provided complementary meals, paid by the Club.
- b) Our speakers are offered a modest honorarium for their time and effort in addressing the Club. Most speakers are not compensated for their total time and expenses which exceed our small fee.
- c) From time to time Club members are offered opportunities for performance and other tickets, such as the Utah Symphony Finishing Touches, University College of Fine Arts events, music, dance, special art exhibits, and museum tours. Our Activities Coordinator can sometimes negotiate a group discount with the hosting organization. At the Board's discretion, the Club also contributes a small discount toward performance costs. (This does not apply to travel tours outsourced through licensed travel providers.)
- d) There are also costs of parking validations, postage, name tags and office supplies.
- e) None of our Club officers receive remuneration for their service, and each pays their own meal costs.

Your participation in paying annual dues is greatly appreciated in helping our Club remain solvent and able to provide these services to our members. — Hyrum Higham, Club Treasurer
